2. Approval of November 4, 2024, Meeting Minutes

3. Citizen Comment

4. Ice Breaker

• Commissioner Chair Flick facilitated a continuation of the activity on Cognitive Bias.

5. Chair Review of LETAC Business

- Commissioner Chair Flick reported on her meeting with CSPD Chief Vasquez as the new Chair for LETAC, where they discussed the implementation of Jiu-Jitsu for officers and her journey to LETAC.
- Commissioner Walker will attend upcoming interviews instead of Chair Flick, who will be out of town.

6. Commissioner Discussion of PERF Report

• Discussion Section I. Introduction



- i. Commissioner Hoskins inquired if there were other research options that CSPD explored aside from PERF.
- Section II. Project Scope and Methods
 - i. Commissioner Burns shared insights from a meeting with four PERF members when the research was ongoing.
 - ii. Observations:
 - Page 15, Figure 2: The report simplifies responses to three categories (Disagree, Neutral, Agree) instead of a five-point Likert scale (Hoskins).
 - Page 16: A significant percentage of respondents feel "not enough is being done."
 - **3.** Page 20, Figure 7: Discussion on data categorization of non-patrol officers.
- Survey Questions
 - i. Commissioner Flick highlighted:
 - Page 106: Discussion on the Critical Decision-Making (CDM) model and how its effectiveness is gauged through interviews.
 - **2.** Page 113, Question 105: Noted as cultural factors.
 - Flick recommended dedicating additional time to review survey findings in future agendas.
- Key Takeaways
 - i. Commissioner Burns: Identified a gap in readiness for use-of-force training, noting potential personal and individual liability.
 - ii. Commissioner Flick: Appreciated the evolution of discussions on qualified immunity vs. criminal liability (post-2017) and feedback on promotion practices.



- iii. Commissioner Hoskins: Advocated for open discussions on decision-making and procedural justice, citing survey findings on external vs. internal perceptions of justice (Page 23).
- **iv.** Commissioner Walker: Emphasized the need for cultural shifts, officer retention, and addressing recruitment challenges.
- Additional Notes:
 - i. Question raised regarding constitutional training materials.
 - ii. Progressed through Page 24 of the report.
 - iii. Agreed to begin with Section IV in the next meeting.
